The bidder shall be responsible for assembly, testing, commissioning, training, drilling of two (2) wells, rig move and rig up of the rig. All the key personnel required shall be provided by the bidder. The minimum key personnel expected are.

- 1. Team leader 1
- 2. Drilling engineer 1
- 3. Mud engineer 1
- 4. Drillers 2
- 5. Derrickmen~ 2
- 6. Directional/MWD engineer 1
- 7. Mechanical maintenance engineer 1
- 8. Electrical maintenance engineer 1
- 9. Cementing engineer (equipment and lab) ~ 1
- 10. Aerated equipment engineer 1
- 11. Any other personnel deemed necessary by the contractor for commissioning and operation of the rig.

The key personnel shall be **fluent in English both written and spoken**. Qualification and experience of the personnel shall be provided.

The contractor shall be able to maintain 24hrs operation during rig drilling operation.

The bidder shall be responsible for safety of the personnel and shall provide appropriate personal protective equipment to his personnel.

The rig shall be supplied complete with a base camp. KenGen expects the bidder to utilize the supplied camp to cater for their staff accommodation and catering services. Transport from base camp to rig site shall be provided by the bidder.

KenGen shall provide diesel and other drilling materials required during commissioning and testing of the rig.
