1.	On the technical requirement number 6 which requires the reference to appendix 7 as stated on the technical evaluation which on the other hand does not give the details of consumables and materials but rather gives the details of technical number 5 of tool, machinery and equipment	TR6 erroneously refers tenderers to Appendix 7, Bidder to Refer to Appendix 8 for Consumables and Materials. TR 6 revised to read; Consumables and Materials. Duly signed and stamped consumables and materials schedule committing to supply the required consumables and materials for the cluster(s)/schedule(s) bid for. (Refer to Appendix 8).
2.	Please confirm the frequency of Garbage collection Services.	The frequency of garbage collection is twice a week.
3.	Kindly advise on a scenario whereby the tenderer is authorized to carry out more than one business by the county government , e.g. provision of technical and professional services	It is acceptable if the bidder's license is for more than one category so long as the cleaning related category is captured in the license. Provision of technical and professional services is rather broad; it would be advisable if the nature of technical and professional services provided are described.
4.	On instructions which says prices must be entered in the items tab must be similar to the price schedule. According to our understanding prices on the hard copy are inclusive of VAT. and prices on the system are normally exclusive so can they be similar?	Please quote as per prices in the Price Schedule of the tender document as this is what will be used for evaluation.
5.	If the current good conduct is expired but the initiative has been taken to renew it. The invoice can be attached in the place of the good conduct?	In instances where issuance of a Good Conduct certificate has delayed, submission of a payment receipt (and not the invoice) for the same shall be accepted.

6.	In the condition that the Director is a Housekeeper and has the Certificates required for the tender. Can the Certificates be valid for the position of a Manager or Supervisor?	The minimum education requirements for Manager is a Diploma Certificate in Housekeeping, Hospitality Management, or an equivalent course. A Certificate in Housekeeping is therefore not acceptable for the level of Manager.
