"	In the Clarification No. 3 we had we had erroneously indicated that 5x964 is correct. But the correct statement is <b>TOTAL PILE FOUNDATION FOR DN 600Diameter PILES (ITEM NO. 6X964)"</b>
2		Provide a clarification regarding the tender's Mandatory Requirement No. 22, namely MR-22 which	This is clarified, refer to <b>Addendum No.6</b>

		<p>indicates that Bidders are to provide:  <i>Duly Signed and notarized Joint Venture (JV) Agreement in case of a JV bid.</i>  <i>NOTE: In the case of a JV, each JV Member MUST individually meet these mandatory requirements, except the Site Visit Certificate.</i>  This contradicts the requirement for MR-2 for a Valid Tax Compliance Certificate which is a uniquely Kenyan and therefore auto-disqualifies Non-Kenyan firms yet this is an International Tender. Firms which are not already operational in Kenya are never issued these two documents. We look forward to your speedy response to this Request for Clarification.</p>	
3		<p>We observe that the wording of this requirement contradicts Mandatory Requirements No.s MR-20 and MR-21 for the provision of NCA-2 or above. This being an International Tender, we request that this requirement should be waived for International Firms because they would be automatically disqualified since NCA-2 or above is a local licensing requirement.</p>	<p>This is clarified, refer to <b>Addendum No.6</b></p>
