Clarification No.3.

In accordance with the Tender for Provision of Cleaning, Garbage Management and Gardening Services for KenGen Premises for The Year 2024~2026. (Re-Tender), KenGen issues Clarification No.3 as follows:

	Bidder's Clarification	KenGen's Response
1.	Under Equipment. Page 209 Item number 17,18, 10 ft ladder,20 ft ladder and page 213 under Tools and Machinery item number 13 ladder	As indicated on page 209, both a 10 foot and a 20 foot ladder are required. These two ladders shall suffice for the ladder requirement in page 213.
2.	2) Page 208 under Equipment vacuum cleaner and page 212 under Tools and Machinery Dry vacuum cleaner. These items have similar usage and are all falling under the same station. That is Kipevu. Since they have the same usage isn't this a repetition.  How about on quoting? Kindly clarify	<ul> <li>a) If one equipment/machine has more than one function i.e. is multipurpose, additional equipment for the other functions of such a machine/ equipment shall not be required e.g. Vacuum cleaner and wet &amp; dry suction machines.</li> <li>b) Bidders are not required to quote for items in Appendix 6 as it is for guidance purposes only, so that bidders may know the tools and equipment required for the job, should they be successful.</li> </ul>
3.	on TR1 and TR2 on page 37 the requirement on NEMA and County Licenses that are required to be of the area of current operation. Does the requirement indicate the areas where the bidder currently has cleaning and garbage collection services or the areas we are bidding for?	The requirement is to have NEMA and County licenses for the bidder's area/s of current operation. These licenses do not have to be for the area of bidder's expression of interest.
4.	On the price schedule of services on page 107 there are entries on one of the columns that bidders are supposed to fill.	This is a formatting error. Bidders are advised to ignore the entries therein and fill in their own prices, VAT inclusive.
5.	We are writing to ask you to clarify on the above two tenders: KGN-ADM-007-2024 and KGN-ADM-008-2024.  The mandatory criteria for a valid trading license that is worded as you have put is against the basic principles of tender criteria. Bidders do not have power to authorize the County Government on what names or codes to use on their licenses. The county governments have their codes for various	Mandatory Requirement No. 6 has been revised to read as follows as per addendum No. 2:  "A copy of valid Business Permit for area/s of current operation.  Note: If the successful bidder does not have a business permit for a cleaning related entity/business, they shall be required to provide a valid Business Permit specific to cleaning/related

business activities and they cannot exhaust all activities in the market and thus most licenses have codes that are close to the main activity of a business and you cannot disqualify a bidder based on the different codes used depending on the County of business location.

Section 80 (3a) of PUBLIC PROCUREMENT AND ASSET DISPOSAL ACT, 2015 states that the criteria shall, to the extent possible, be objective and quantifiable;

business within three months. Also, in such an instance, the successful bidder shall be required to provide proof of payment (e.g., official receipt) within one month after contract signing."
